

# Bolnuevo Cars SL

## CONTRATO DE ALQUILER DE COCHE

BOLNUEVO CARS S.L. rents the vehicle to you subject to the terms and conditions of this rental agreement. Please read them carefully before signing to accept them.

### 1/ Your Responsibility:

You must pay on demand the amount of all costs and losses incurred by us including and not limited to the costs of repairs, loss in value, loss of rental income, towing and stowage charges. This will be avoided provided that the loss or damage is not intentional.

You agree that we may debit your account with the above amounts, and that we may charge you the actual cost of any repairs incurred by us.

### 2/ Delivery and Return

The vehicle is in good overall condition and you agree to return back to us in the same condition with all the documentation and accessories at the location time and date designated on the agreement. We can collect the vehicle at any time if you are in breach of this agreement without notice.

### 3/ Our Responsibility

We are not LIABLE for any loss.

### 4/ Tariffs, Charges

All charges will be made in accordance with our current charge brochure.

You agree to pay on demand:

- The rental and any tariff in respect of collision damage waiver, theft, collection and delivery of vehicle as per tariff, and taxes. The minimum charge is for three day's rental starting from contract time. In the event of a late return of more than 2 hours we reserve the right to charge another full day's rental (24 hours) at the going rate.
- All rental cars are regularly supplied with a full tank of fuel and should be refuelled prior to return to Bolnuevo Cars S.L. otherwise fuelling charges apply. Alternatively, you may purchase your fuel in advance. Please ask for details of the Pre-Paid Fuel Option.
- Any charges arising from the Police, Customs, together with the loss of vehicle rental should the vehicle be seized.
- If you default you will be charged interest @ 3% per year above the basic Sol bank lending rate, without formal notice.

All complaints must be brought to our attention within 7 days of final contract or will be conclusive

All charges are subject to final determination after the rental. You authorise us in advance to debit any charges to this agreement from your credit or debit card account including our legal costs and recovering charges.

### 5/ Traffic Regulation Violation

You are responsible for any fines and consequences of the violation of traffic regulations and parking tickets or prohibitions during the rental agreement. If Bolnuevo Cars S.L. has to pay such fines you agree we may debit your credit or debit card during or after the rental period of the vehicle, with the amount of any fine plus 20% handling charge. We will on request supply a copy of the fine we receive.

## 6/ Indemnity

To the extent allowed by law, you agree to indemnify us against any claims in connection with the operation of the vehicle, any damages suffered by you, including without limitation, the fines and other consequences referred to in clause 5 above, or any matters which are your responsibility. To the extent allowed by law we disclaim any liability for damage or loss of any kind suffered by you or any third party, unless we are at fault.

## 7/ Conditions of use

You must look after the vehicle, making sure it's locked up and secure and any security devices are used. You use the correct fuel; we will not be responsible for any garage expenses for repairs to the fuel system if the wrong fuel was placed in the vehicle.

You must not use or allow the vehicle to be used:

- To carry passengers for hire or reward
- To tow a trailer or any other vehicle.
- To race, rally, test or contest.
- While the driver is under the influence of alcohol or drugs or any other substance impairing his or her consciousness and ability to react.
- In contravention of any traffic regulations, note that any traffic offence is in breach of this contract.
- If you do not meet the age requirement and current driving licence.
- By any other person not being authorised by us on the agreement
- For sub renting
- To drive in restricted areas
- Off road

## 8/ Insurance

We provide insurance cover for those persons using the vehicle with our permission. This policy meets the legal requirement and protects the owner and / or any authorised driver of the vehicle against any legal claims from third parties for personal injury or material damage caused by the vehicle.

## 9/ Accidents

You must report any traffic accident, loss, damage or theft to the Police and to us immediately. An Accident / theft form must be completed and submitted to us. You agree to co-operate with us and our insurers in any proceedings

## 10/ Personal Property

We are not liable to you or any other passenger for loss or damage to property left in the vehicle at any time during or after the contract/agreement.

## 11/ Law

The law of the country where you signed the rental agreement will apply and the courts of that country will have jurisdiction.

The client is responsible for all costs and legal fees that may arise from breach of this contract.
